

DECISION OF THE GOVERNOR OF YOGYAKARTA SPECIAL REGION No. 235 / KEP / 2016 ON DISTRICT/CITY MINIMUM WAGE FIXING 2017

THE GOVERNOR OF YOGYAKARTA SPECIAL REGION

Considering:

that in order to implement the provisions in Article 2 (4) of The Governor Regulation No. 74 of 2016 on Minimum Wage, it is necessary to have a governor decision on 2017 District/City minimum wage fixing;

In view of:

- 1. Law No. 3 of 1950 on the Establishment of the Special Region of Yogyakarta (Official Gazette of the Republic of Indonesia 1950 No. 3, as last amended by Law No. 9 of 1955 concerning changes to Law No. 3 in conjunction with Law No. 19 of 1950 on the Establishment Yogyakarta Province (State Gazette of the Republic of Indonesia of 1955 No. 43, Supplement to State Gazette of the Republic of Indonesia No. 827):
- 2. Act Number 13 of 2012 on Privileges for Yogyakarta (State Gazette of the Republic of Indonesia of 2012 Number 170, Supplement to State Gazette of the Republic of Indonesia Number 5339);
- 3. Law Number 23 Year 2014 regarding Regional Government (State Gazette of the Republic of Indonesia of 2014 Number 244, Supplement to State Gazette of the Republic of Indonesia Number 5587), as amended by Law No. 9 of 2015 concerning Second Amendment Act Number 23 of 2014 regarding Regional Government (State Gazette of the Republic of Indonesia Year 2015 Number 58, Supplement to State Gazette of the Republic of Indonesia Number 5679 4. Government Regulation Number 31 of 1950 regarding
- 4. Government Regulation Number 31 of 1950 regarding the enactment of Law No. 2.3 10 and 11 in 1950 (Gazette of the Republic of Indonesia Year 1950 Number 58);
- 5. Governor Regulation Number 74 of 2016 concerning Minimum Wage (Regional Gazette Yogyakarta of 2016 Number 74);

DECIDE

to Enact:

ONE : District/City Minimum Wages for 2017, with the amounts as

stated in the Appendix which is an integral part of this Decision.

TWO : Upon the effective date of this decision, Yogyakarta Governor

Decision No. 255/ KEP / 2015 on the District/City minimum wage for 2016 in Yogyakarta is then revoked and declared

invalid.

THREE : This decree comes into force on January 1, 2017
